WHEREAS, the Board of Directors has established the position for Paid Call Personnel to ensure continued operations of the District; and

WHEREAS, the Board of Directors is authorized to establish such stipend for personnel as defined in the Health and Safety Code 13800 et seq.;

WHEREAS, the Board of Director's deems it appropriate to provide such stipend to District personnel, for reimbursement of reasonable expenses such as meals, laundry, clothing, insurance, maintenance of vehicle, classes and training, to maintaining certifications and other related reimbursable expenses;

WHEREAS, the Board of Directors rescinds BFPD Resolution 2009-3, and

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Burney Fire Protection District does here by adopt the salary range shown on Exhibit A.

Paid Call EMS personnel per diem

24-hour shift stipend \$200 or 12-hour shift stipend \$100
\$25.00 per call of second out ambulance requests

Fire Paid Call Personnel Stipend

Firefighter Trainee	\$15.00 per call or on-site weekly training
Firefighter	\$20.00 per call or on-site weekly training
Fire Operator (Driver)	\$25.00 per call or on-site weekly training
Captain	\$35.00 per call or on-site weekly training

Duty Officer

\$100.00 per 24-hour shift stipend or \$50.00 per 12-hour shift stipend plus per call pay at rank.

*If hours are less than the 24 or 12 hour the hours worked will be prorated by dividing the hours works by the stipend assigned to the shift.

EMS/Fire Personnel are required to complete their daily duty list when not on calls.

WHEREAS, the Board of Director's deems it appropriate to provide such stipend to District personnel, for reimbursement of reasonable expenses such as meals, laundry, clothing, insurance, maintenance of vehicle, classes and training, to maintaining certifications and other related reimbursable expenses;

WHEREAS, paid call personnel are considered volunteers and not employees as defined under the Department of Labor guidelines;

NOW, THEREFORE, BE IT RESOLVED THE BURNEY FIRE PROTECTION DISTRICT BOARD OF DIRECTORS ESTABLISHES THE COMPENSATION STIPEND AS STATED IN ATTACHMENT A AND INCORPORATED HEREIN OF THIS RESOLUTION.
