13. DISCUSSION/ACTION ITEMS

a. Volunteer Fire Capacity Grant: Resolution 2024-05

The Volunteer Fire Capacity Grant is a matching grant for the purchase of structure turnouts (coats and pants). The grant amount is \$8,750.00. Each set of turnout safety clothing costs an average of \$1,750.00. The grant will allow the District the ability to buy five sets. The District's share will be \$8,750.00. The matching District funds will come from the 24-25 fiscal

budget safety account. In 2022 the District was able to secure a similar grant for wildland safety clothing.

b. Separation from PERS

Several months ago, the Board of Directors wanted to know the feasibility of withdrawing from PERS to help with recruitment. The District contacted PERS and learned that there are several steps required before separation can be considered.

The District also contacted a city that has withdrawn from PERS and utilizes another source of insurance for their employees.

The Board requested that the Fire Chief make a comparison of the options.

c. Fiscal Year 23-24 Audit

The Auditor had not completed the final Audit before the Board Meeting date. The Audit will be brought to the next Board meeting on October 15th.

d. Burney Forest Products Confined Space Standby Agreement

For the past several years, the District has been providing Confined Space Standby services to Burney Forest Products. The current agreement expired on June 30, 2024. Staff prepared a new agreement which has been reviewed and accepted by Bruce Hornbuckle, Plant Manager. The only exception is changing the Net payable from 30 to 60 days.
